What is a CoC?



1987

First federal law specifically addressing homelessness: McKinney-Vento Homeless Assistance Act



2009

May 2009 - the Homeless

programs

July 2012 - CoC Program

What is a CoC?

66 The CoC program promotes a community-wide commitment to end homelessness. It provides funding for nonprofit providers. It also funds State and local governments to quickly rehouse homeless individuals and families. 99

Provider agencies strive to:

- Minimize the trauma and dislocation caused to homeless individuals, families, and communities
- Promote access to and use mainstream programs by homeless individuals and families
- Optimize self-sufficiency among individuals and families experiencing homelessness.



What is a CoC?

Our CoC is a "Balance of State"

A Continuum of Care (CoC) is the group organized to carry out the responsibilities prescribed in the <u>CoC</u>

<u>Program Interim Rule</u> for a defined geographic area.

Balance of State Continuum of Care programs are comprised of counties not covered by another CoC.

This is often areas with a lower population density compared to metro areas.

As of May 2025, there are 8 CoC's in Oregon

Central Oregon (Crook, Deschutes, Jefferson Counties), Clackamas County, Jackson County, Lane County, Portland/Multnomah County, Salem - Marion - Polk, Washington County, Balance of State (26 Counties - Baker, Benton, Clatsop, Columbia, Coos, Curry, Douglas, Grant, Gilliam, Harney, Hood River, Josephine, Klamath, Lake, Lincoln, Linn, Malheur, Morrow, Sherman, Tillamook, Umatilla, Union, Wallowa, Wasco, Wheeler, Yamhill)




Image shows map of state of Oregon with the 8 CoC's highlighted in grouping colors.




What does a CoC do?



Operating the CoC

The CoC operates via CoC Board to build stronger systems to solve houselessness within the continuum via planning activities, HMIS, and funding



Designates and Operates HMIS

The CoC houses the Homeless
Management Information System and the
CoC Board chooses which HUD compliant
provider for the system



Plans for the CoC

Planning coordinates the implementation of a housing and service system within its geographic area that meets the needs of the individuals and families who experience homelessness there



What does a CoC do?



Design and Implement Funding Methods for CoC Program Funding

The CoC Board is responsible for identifying the priorities and methods for applying for CoC funds through the CoC Program. The priorities and methods vary from each CoC funding cycle depending on the preferences of the Governing Board.



Lead the PIT Count

The CoC leads the coordination of the annual Point in Time (PIT) Count that provides a count of the homeless individuals and families living in a geographic area on a given night.





What does a CoC do?

This infographic provides insight into the healthy housing continuum. The CoC touches all parts of the continuum from unhoused to stably housed. The goal of the Continuum of Care Program is to accomplish a healthy continuum where all aspects are present in the geographic area that the CoC serves to meet the needs of the community.

CoC Board & Collaborative Applicant

These two parties oversee governance and funding applications.

Native Tribal Organizations

Indian Tribes or tribally designated housing entities that assist Native American communities.

US Dept Housing & Urban Development

The CoC reports to HUD and must follow all compliance regarding program delivery and planning

Health Services Providers

Healthcare service providers such as mental health professionals, hospitals, substance abuse counselors, and employment assistance programs.

State Agencies

Some CoC's may be funded by agencies like OHCS in Oregon. These are separate funds subject to that agency's policies.

Clients and Champions

Individuals with lived experience of homelessness, who contribute valuable insights to policy and program development.

Local Govt Leaders

Local governments within the geographic area that help implement policies and allocate funding.




PIT Count

The CoC coordinates the Point in Time Count

The Oregon Community Continuum of Care coordinates the implementation of the PIT Count annually. The CoC Board:

- Approves the purchase of the program to collect digital surveys
- Leads data clean up and HUD reporting
- Supports training and technical assistance
- Provides day of on the ground support to agencies
- Advocates for participation in the count
- Schedules live one-on-one and group virtual trainings for agencies





HMIS & Coordinated Entry

Coordinated Entry

Coordinated Entry (CE) is the process by which clients in need of housing services enter into the process of receiving assistance. At this time, CE is undergoing changes and remains fluid for OC3.

HMIS is a database

HMIS is an information technology system used to collect client-level data and data on provision of housing and services to homeless individuals and families, and persons at risk of homelessness. The CoC Board is responsible for voting on the provider used for this database, as well as managing the system to meet the CoC's needs. All providers except DV are required to submit data into HMIS for their housing program. CoC staff provide training to new agency users and help to run reports and provide data for agencies to utilize.






Image shows the difference in accessing services with coordinated entry and without
